This project will prep and complete a coated chip seal on Main Street from 7th Street to 10th Street.

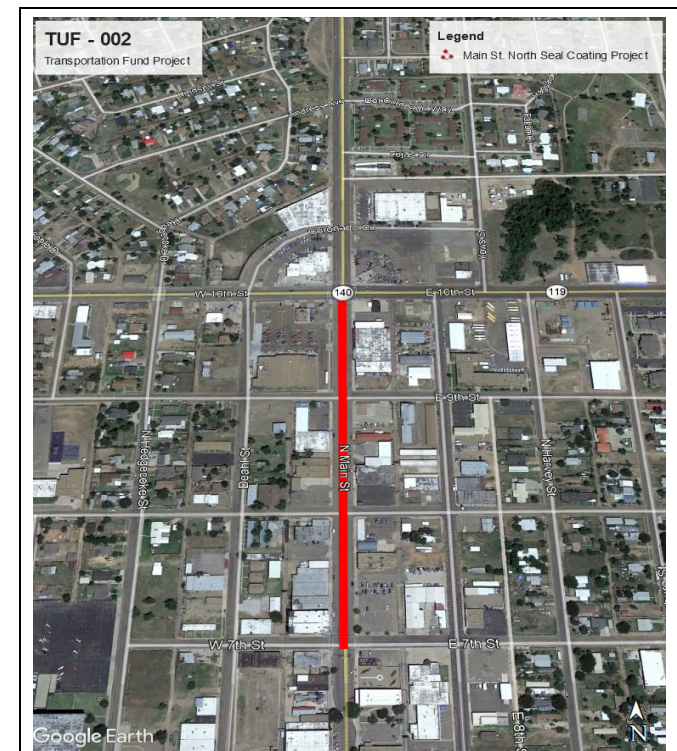
**Justification**  
The 2018 Street assessment rated North Main Street with a Pavement Condition Index (PCI) Value of 61 placing this segment in the fair category. This stretch of Main Street averages over 16,000 cars per week, making it one of the busiest streets in Borger and prioritizing it for maintenance and repair.
